Community service is completed to benefit the community at a non-profit agency or organization where you receive no compensation or payments for the time spent working. You may not complete community service at your place of employment, through your employer, friends, or family.

YOU WILL BE CREDITED \$11.00 PER HOUR OF COMMUNITY SERVICE COMPLETED. THE COURT MAY DECLINE TO CREDIT ANY COMMUNITY SERVICE HOURS COMPLETED AT ANY SITE THAT IS NOT A NON-PROFIT OR IS OTHERWISE DEEMED INAPPROPRIATE BY THE COURT.

COMMUNITY SERVICE HOURS <u>WILL NOT</u> BE APPLIED TO SATISFY RESTITUTION ORDERS.

COMMUNITY SERVICE HOURS CANNOT BE COMPLETED ONLINE!

The Community Service Time Sheet provided by the Court must be signed by your immediate supervisor at the non-profit agency or organization site(s) selected. You are responsible for filing the completed time sheet with the Fauquier County General District Court by the due date.
