

## **Northampton Juvenile and Domestic Relations District Court Family Abuse Protective Order Filing Information**

### **1. Is there a fee for filing for a Family Abuse Protective Order with the court?**

No, there is no fee for filing a petition with the court for a Family Abuse Protective Order (*A petition is a formal written request asking the court to do something*).

### **2. What should I do if I have used the on-line I-CAN! Virginia system to produce my protective order petition forms/documents?**

You may bring the documents to the Court Services Unit at the Northampton County Juvenile and Domestic Relations District Court. The Court Service Unit will review the documents and file them with the clerk of court.

You may also bring these documents to the Eastern Shore Coalition Against Domestic Violence (ESCADV) who will assist you in filing for a Family Abuse Protective Order.

### **3. What should I do if I have not used the on-line I-CAN! Virginia system to produce documents?**

You should go to the Court Service Unit for the Northampton County Juvenile and Domestic Relations District Court. The Court Service Unit will assist you in completing the correct documents and filing them with the clerk of court. If possible, please call ahead to let the Court Service Unit know you are coming at 757-678-0481.

The Court Service Unit is located next to the County Courthouse.

## 5. What are driving directions to the Court Services Unit and Courthouse?

### Directions:

#### **From the North:**

- **Take US Rt 13 south** Go to the traffic light at the intersection of US Rt. 13 (Lankford Highway) and Rt. 631 (Willow Oak Road). On the **left** south corner will be PNC Bank, and on the **right** southwest corner will be a Valero/Shore Stop convenience store.
- Turn **right** west (past the convenience store) onto Willow Oak Road, and go to the end of the road to the T-intersection (Courthouse Road, not marked). Turn left on Courthouse Road, and then immediately right, just past The Eastville Inn. The new Northampton County Courthouse and the new Court Services Unit will be straight ahead at the bottom of the hill.

#### **From the South:**

- **Take US Rt 13 north** to the traffic light at the intersection of US Rt. 13 (Lankford Highway) and Rt. 631 (Willow Oak Road). On the right (southeast) corner will be PNC Bank, and on the left (southwest) corner will be a Valero/Shore Stop convenience store.
- Turn left (west) past the convenience store onto Willow Oak Road, and go to the end of the road to the T-intersection (Courthouse Road, not marked). Turn left on Courthouse Road, and then immediately right, just past The Eastville Inn.

The new Northampton County Courthouse and the new Court Services Unit will be straight ahead at the bottom of the hill.

## **6. Where can I park?**

Parking is available in the parking lot in front of the Courthouse. Both the Courthouse and County Administration Building are handicap accessible and there are marked "Handicap" parking spaces available.

## **7. What bus transportation is available to the Courthouse and what does it cost?**

Star Transit is an Eastern Shore based bus system that runs 3 routes in Northampton Co. and 1 route in Accomack County.

## 10. What should I do if I don't understand or speak English well?

To file for a Family Abuse Protective Order, please bring someone with you who understands English and can translate for you. If you are appearing in court for a hearing, you should let the court know as soon as possible that you will need assistance. For a full court hearing, the court will provide translation services free of charge. Please call the clerk of the court at 757-678-1269 ext. 1 to alert the court of your need for assistance.

The Eastern Shore Coalition Against Domestic Violence (ESCADV) has a Spanish speaking advocate on staff who may be of assistance. Contact ESCADV at 787-1329 or toll free at 877-787-1329.

## **11. What should I do if I need help because of a physical challenge?**

The Court and Court Services Unit are both handicapped-accessible, with ramps at the doors, handrails and an elevator to the second floor. If you feel you will need special assistance, please call clerk at 757-678-1269 ext. 1 ahead to make arrangements to meet your needs.

## **12. What should I wear to court?**

Proper attire is required. Please do not appear in:

- Shorts
- Halter or tank tops
- Flip flop shoes
- Hats
- Explicit T-shirts or tops
- Ripped or torn clothing
- Exposed undergarments

No food, drinks, or gum are permitted in the Courtrooms.

## **13. What should I bring with me?**

A full description of the event that led you to seek a protective order. If you used the I-CAN system, bring the Affidavit with you. **YOU WILL BE REQUIRED TO TESTIFY AT ALL HEARINGS AND WILL NEED THIS INFORMATION FOR ALL HEARINGS.**

The name and physical address (not a P.O. Box) of the person from whom you are seeking protection.

You should also bring with you as much identifying and contact information as possible about the person from whom you are seeking protection – this information is very important because the Sheriff must be able to find this person for the Protective Order to take effect. **PLEASE GIVE:**

- nicknames, aliases;

- home, work, cell phone and pager numbers;
- addresses and directions for home, work, friends, relatives, and places frequented;
- age, height, weight, eye color, hair color, distinguishing marks;
- birth date, social security number; and
- history of drug or alcohol abuse.

#### **14. What should I NOT bring with me?**

The Court Service Unit prohibits weapons, food or drink. Use of tobacco products is not permitted in the building.

The Court prohibits ANYTHING that could be used as a weapon including but not limited to: firearms, knives, scissors, nail trimmers and knitting needles. Cell phones and cameras are not allowed in the courtroom unless they are required for evidence such as pictures, voice mail or text messages. If a cell phone or camera will be used as evidence, tell the Deputy Sheriff at the door.

You are discouraged from bringing infants and children to court with you. If you must bring them, please bring an adult to supervise the children while you are in the courtroom.

Do not bring friends or family members who may cause a disturbance at the courthouse.

#### **15. Who should I bring with me to court?**

Any witnesses to the abusive event, and anyone you might need for moral support.

#### **16. What days can I file for a Family Abuse Protective Order at the Juvenile and Domestic Relations District Court?**

The Court Service Unit is open Monday through Friday (except holidays) from 8:15 AM to 4:45 PM. To file and have the petition reviewed the same day, you must arrive by 3:00PM. If possible, please call ahead to let the Court Service Unit know you are coming by calling 757-678-0481.

**17. How early can I arrive at the Court Service Unit to file for a Family Abuse Protective Order?**

You can arrive as early as 8:30 AM.

**18. How late can I arrive and have the petition reviewed by a judge the same day? (*A petition is a formal written request asking the court to do something*)**

You must arrive at the Court Service Unit by 3:00 PM in order to file a petition for a Family Abuse Protective Order and have the petition reviewed by a judge the same day.

**19. How long should I expect to spend at Courthouse to file for a petition and have it reviewed by a judge the same day?**

You should expect to be in the Court Service Unit with the Intake Officer for at least thirty minutes. The Court will try to consider the petition as soon as possible after it has been brought to the Juvenile and Domestic Relations District Court Clerk's Office. If the Court's morning docket is full, you will be asked to return sometime in the afternoon. Anticipate spending at least 2 hours at the Courthouse.

**20. Where should I go after passing through the security check at the door?**

The Juvenile and Domestic Relations District Court is located upstairs in the new courthouse. Once you pass through the security check point, go left. You will have the choice of using the stairs or use of the elevator. Once upstairs, proceed to the area labeled Juvenile & Domestic Relations.

**21. What should I do if I am the person named as a "respondent" (the person against whom the protective order is issued) in a Family Abuse Protective Order?**



You received a copy of the order the Sheriff or other official. Read it carefully. Strict compliance with the order will avoid additional problems that can result in criminal penalties.

If the order has a date and time for a hearing, arrive at the Courthouse at least 30 minutes ahead to allow time for parking. You or your attorney may present your case (tell your story) at the hearing.

You may ask the court, by filing papers with the clerk, to dismiss or change the terms of the order. **ONLY a judge** may dismiss or change the terms.

You will find the location of the court and other information about the court's policies in this document under separate questions.

**Call 911** first.

**24. What should I do if an Emergency Protective Order expires before I can have a petition for a Family Abuse Protective Order filed and reviewed by a judge? (*Emergency Protective Orders are most often issued by Magistrates and may last only 72 hours*)**

Emergency Protective Orders are issued by Magistrates and expire after 72 hours. They sometimes are in effect longer than 72 hours, only when the 72 hour time limit falls on a weekend or other date the court is closed. ***The expiration date/time is clearly indicated on the Emergency Protective Order.*** These Emergency Protective Orders (EPO's) are the only such orders that a magistrate has the authority to issue.

Only in very few circumstances can a magistrate re-issue an EPO, ***therefore it is important to have a petition for Family Abuse Protective Order entered BEFORE the expiration of the EPO.***

In those unusual circumstances when the EPO has expired before a petition for the Family Abuse Protective Order is in effect, and you have been unable to get to the court or other "I-CAN" location, you may go to the magistrate's office and testify under Oath as to why the EPO expired before you were able to get to court. It is up to the magistrate whether they will re-issue.

You may wish to contact the Eastern Shore Coalition Against Domestic Violence; 757-787-1329 who can assist you with using I-CAN! Virginia system to prepare documents to file for a Family Abuse Protective Order, provide emergency shelter and help you develop a safety plan.

## 25. How do I contact the Magistrate’s Office for more information?

In Northampton County, there is a Magistrate’s Hearing Room located off the lobby of the Eastern Shore Regional Jail in Eastville. You will either speak to a magistrate in person, or by way of video-conferencing to the magistrate in the Accomac office or from another district. Whether you see a magistrate via video or in person, each accomplishes the same purpose. Magistrates are available 24 hours a day, seven days a week.

## 26. Do I need a lawyer to file for a Family Abuse Protective Order?

You do not need a lawyer to file for a Family Abuse Protective Order. The Court Service Unit intake officer or Eastern Shore Coalition Against Domestic Violence will provide assistance to help you complete the necessary paperwork and will provide basic information about preparing for your court hearing. The intake officer and Coalition, however, cannot give you legal advice. You may want to retain an attorney to represent you at your full hearing, especially if the person from whom you want protection will have an attorney (see question 26).

## 27. How can I find a lawyer to help me?

Legal Aid may be able to provide assistance to those who are eligible for their services, 757-442-3014. Their office is in the Colonial Square Shopping Center, 36314 Lankford Highway, Suite 5, Belle Haven, Va. 23306.

#### Eastern Shore Public Library Internet Policy:

- All copyright and communication laws must be obeyed.
- Patrons may not view, send, receive, or download illegal material; use any library workstation for illegal or criminal purposes; or represent themselves as another person for purposes of fraud or other illegal activity.
- Patrons may not view inappropriate materials, defined as text or graphics which may reasonably be construed as obscene.
- Patrons may not use the library's workstations as a staging ground to gain unauthorized access to the library's networks or computer systems or to any other network or computer system.
- Patrons may not use any hardware/software other than that supplied by the library. Users may not load their own software or connect their own equipment to library computers.
- Patrons may not change ANY settings on the Internet browser without permission.
- Patrons may not make any attempt to damage computer equipment or software or make any attempt to alter software configurations.

#### RULES FOR USE:

- Access – Please sign in at the circulation desk. Anyone wishing to have access to the Internet must present his or her own valid library card and leave it with a staff member for the duration of the session. Nonresidents must present a picture ID (driver's license or other government issued ID). Nonresident minors must show proof of age.
- Users under 18: Children aged 12 and under will be permitted to use an Internet computer only if accompanied by an adult 18 years or older. Thirteen to seventeen year-olds may use an Internet computer by themselves only if a parent or guardian has come to the library and signed a permission slip.

- Time Limits: Users are limited to 30 minutes (including printing time) at each session if all Internet workstations are in use. If a computer is available after 30 minutes of use, a patron may continue to use the computer until it is needed by another patron.
- Crowding at Internet terminal: There is a limit of two people per workstation (with the exception of an adult working with children).
- Ending session: Users must end their Internet session by returning to the homepage.
- Saving work: Patrons must use their own disks when saving information. Any data left on a computer's hard drive will be deleted. Pre-formatted disks are available at the circulation desk for \$1 each.

**Eastern Shore Community College** will allow access to the computers and printers in the library for those wanting to use the I-CAN! Virginia System. Users must check with the employee at the front desk in the library. Community College library hours are 8:30 AM to 7:00 PM except for school holidays.

### 30. Where else can I get help?

**The Eastern Shore Coalition Against Domestic Violence** provides emergency shelter for victims and their children. The Coalition also provides counseling, case management, 24-hour hotline, crisis intervention, legal advocacy, systems advocacy, referral, information, prevention services, outreach services and emergency transportation. The Coalition may also provide financial assistance for utilities (when a disconnect notice has been received) and rent or mortgage assistance (to prevent eviction or foreclosure) when funding is available. The Coalition has a Spanish speaking advocate on staff and also contracts with the Language Line for any other language needs.
