

**Introduction** Since the inception of the Court of Appeals (CAV) in 1985, case filings have increased from 1,641 to 2,090 in 2019, an increase of 27.4%. The highest recorded number of cases filed in the CAV (3,499) was in 2001. Between 2015 and 2019, total cases filed remained around the same levels. Petitions refused and cases disposed collectively have tripled since 1985 from 689 to 2,163. This caseload statistical review focuses on the caseload trends and types of case filings between 2015 and 2019 in the CAV.

**Cases Filed and Disposed** The table above (Table 1) shows an overview of the case filings for the CAV for the past five calendar years. In 2019, the CAV recorded 2,090 case filings, 70 more than the 2,020 in 2018 and 17 more than the 2,073 in 2015. Between 2018 and 2019, the increase in cases filed was driven by increases in criminal petitions and domestic relations case filings, as well as concealed weapons applications, appeals by the Commonwealth before the end of trials, and contempt. Final dispositions totaled 2,163 in 2019, 199 more than the year before and 143 less than 2015. Of the final dispositions, 74.1% were criminal cases. Since 2015, criminal dispositions have decreased 5.9%, while non-criminal dispositions decreased 13.2%. During the five years, filings have increased less than 1.0% and final dispositions have decreased 6.2%.



**Case Filings Mix** Between 2015 and 2019, the majority of the cases filed in the CAV consisted of criminal petitions, domestic relations, and Workers' Compensation Commission cases. In 2019, Worker's Compensation Commission cases decreased by 14 cases filed or 12.8% since last year and decreased six cases filed or 5.9% since 2015. The percentage of criminal petitions in 2015 was 72.9%, which rose to 74.1% in 2019. The combined percentage of domestic relations and Workers' Compensation Commission cases filed remained about the same at 16.3% of filings in 2015 and 16.7% Display 2



**Criminal Petitions** Of the cases filed, criminal petitions including contempt constituted the majority of the filings, 76.2% in 2019. That same year, criminal petitions rose 2.5%; conversely, granted criminal petitions increased 24.7%, increasing from 150 in 2018 to 187 in 2019.

**Original Jurisdiction** In 2019, the total original jurisdiction cases filed was 32 which is nine or 28.0% more than 2018, and five or 18.5% more than 2015. Between 2018 and 2019, the number of actual innocence original jurisdiction case type increased while habeas corpus and mandamus/prohibition decreased.

**Appeals of Right** In 1985, there were 538 appeals of right and in 2015, there were 501, a decrease of 6.9%. In 2019, there was an increase of 3.5% from 2018 for total appeals of right filings. While Workers' Compensation Commission cases had continued to experience decreases between 2015 and 2017, there was an increase in 2018. In 2019, there was a decrease of 12.8% in Workers' Compensation Commission cases. The "other" category that includes concealed weapons applications and civil contempt cases decreased in 2019 by 40.0%.

**Disposition of Appeals** In 1986, the first year detailed disposition data was provided in the *State of the Judiciary Report*, there were 328 cases involving appeals of right or granted criminal appeals decided by opinion and 386 cases decided by order. Each of the 10 judges averaged 33 opinions and 39 orders, an average of 71 dispositions per judge. In 2019 with 11 judges, the average disposition per judge (58) was below the 1986 average. There was an average of 27 opinions per judge and 30 orders per judge in 2019 with the total disposition of appeals being constituted of approximately half opinions and half orders.
